- **Eligible employees:**
 - Current employees with domestic or international commercial passenger airline carrier and are new guests to Crystal Cruises.
 - Past Guests who are Crystal Society members are eligible for Interline rates unless they have, or have had, a full-fare reservation on the desired Interline-rate voyage.
 - The spouse and parents of qualified Interline guests may travel unaccompanied by the Interline guests.
 - Pilots who are currently employed with a domestic or international cargo airline, such as Federal Express, DHL Worldwide Express, Astar Air Cargo or United Parcel Services (UPS), are eligible to book one stateroom.
 - Retired airline employees and retired cargo airline pilots are eligible to book one stateroom provided the airline is still in operation (e.g. retired employees of Eastern Airlines do not qualify).

- Qualifying agents must submit a letter of employment verification to agency at the time of booking in order to apply interline rate. Cruise information is subject to availability and not guaranteed. Application of Interline fare will be dependent on employment verification.
- All fares are cruise only, per person, based on double occupancy and are in US dollars. Final stateroom assignments are at the discretion of Crystal Cruises.
- Interline and other reduced non-full-fare rates are not applicable with Crystal Society Milestone Program including milestone accruals and benefit redemption. Ask for details.
- Crystal Esprit rates are for category S4.
- Singles will be priced at 200% of the offered double occupancy per person Interline fare. Third berth guests will be priced at the offered double occupancy Interline fare, regardless of age.
- One stateroom per qualified airline employee, with spouse or accompanying guest traveling in the same stateroom as the airline employee.
- Port, Security and Handling charges (P,S&H Charges) are in addition to the Interline fare and will apply on a per person basis.
